

Here's What You Should Know About The New Texas "Safety Responsibility Law"



Enforcement Begins January 1, 1952. On this date, the new Safety Responsibility Law, as passed by the Legislature, goes into effect. This law was designed to protect you against financially irresponsible drivers and owners of motor vehicles involved in accidents. It affects all drivers and motor vehicle owners (except Federal, State, County and City-owned cars).

What Must You Do After An Accident? Under exisiting laws, you must file a written report to the Department of Public Safety if your car is involved in an accident where there is a death, an injury or property damage in excess of \$25. Under the new law, a written report must be filed within ten days if your car is in an accident resulting in death or injury, or property damage in excess of \$100.

led the scoring for the losers with five tallies. The score at halftime was 8-7 n favor of the final winners.


Football
