Penalty Fee Waived For Language Tests

Penalty fee for administration of the Jan. 31 Graduate School Foreign Language Tests here has been waived, according to an Educational Testing Service official.

Philip R. Harvey, ETS program director of the graduate tests, indicated that students who took the Dec. 6 test have not received test scores due to a computer system conversion.

"This may mean that some students who are waiting for December results before deciding to retake the test in January may miss the deadline through no fault of their own," Harvey said.

ETS, therefore, waived the penalty fee for the January administration of the test.

"Those candidates who register for the January GSFLT and then learn they passed the language requirement through the December administration will be refunded the full examination fee upon request," Harvey added.
