Oklahoma judge sets rules for use of anti-cancer drug

OKLAHOMA CITY — Cancer patients must use a special affidavit signed by a doctor if they wish to import the banned drug laetrile, a federal judge ruled yesterday.

U.S. District Judge Luther Bohanon wrote the affidavit and filed it with the court clerk.

He met Monday and yesterday with cancer patients who seek to import the drug and attorneys for the

Food and Drug Administration, which has banned laetrile.

The meetings were prompted by attorney Kenneth Coe's claim that the FDA was adding restrictions to Bohanon's April 8 order establishing requirements that terminal cancer patients must meet before importing the drug.

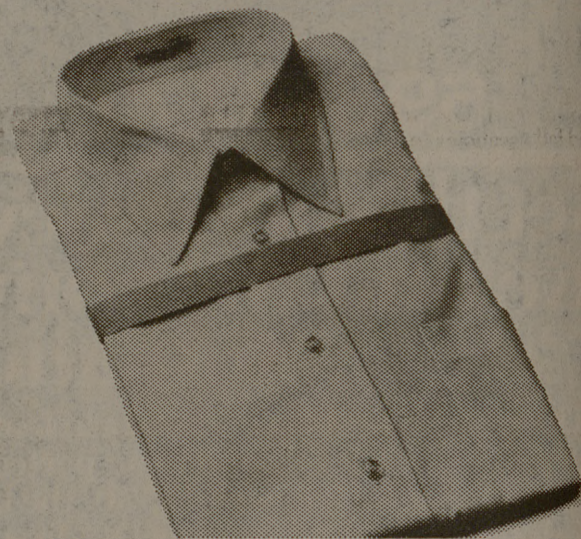
Coe claimed yesterday's order meant practically anyone in the country could get laetrile.

The judge also said the drug laetrile to be imported should be in a six-month supply, not to exceed 500 milligrams per 1,500 cubic centimeters of injectable liquid.

FDA attorney Paul Ragan, assistant U.S. Attorney William thought it a victory for the patients be examined only by licensed physicians.

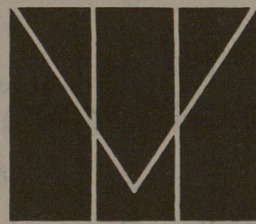
