Texas has not executed anyone since a 1964 Supreme Court ruling voided most capital punishment laws. For a while, the death row population was relatively stable. But inder new law, it's growing again.

Corrections spokesman Ron Taylor said. "We've had to expand to another cellblock and when we reach 120, we will have to expand to a third cellblock."
