## **Blood type frees man** serving life sentence on charge of rape

United Press International FLINT, Mich. — John Henry Harrison, convicted and sentenced to life in prison for the rape-slaying of a 16-year-old babysitter, is a free man today because of his blood

Harrison spent eight months in prison researching and preparing a petition to the trial judge, proving his blood type was not the same as that used as evidence against him. Genesee County Prosecutor Robert Leonard reluctantly agreed Harrison had proved his case and ordered the 45-year-old former truck driver released from custody Tuesday.

Harrison's blood was never typed during his trial. He learned of the discrepancy only after he was issued a prison identification card listing his blood type.

His release marked the end of a bizarre case that began March 3, 1970, when Jan Logsdon, 16, disap-


peared while babysitting. The key testimony against Harri-son in his 1971 trial before Genesee County Circuit Judge Thomas C.

Yeotis came from a crime laboratory analyst with the Michigan Department of Public Health The analyst said saliva samples from Harrison indicated his blood

type was O-positive. After more than a year in the Southern Michigan Prison at Jackson, Harrison was issued an identification card showing he had A-positive blood type.

The prosecutor said Wednesday it would be impossible to retry Harri-son, even though he said he still be-

lieved Harrison was guilty. "There is no way I could get a conviction," said Leonard. "Even if the other evidence stood up, what's important is that an expert has totally excluded the defendant. All the rest of the case is circumstantial and could be totally coincidental."
