Wayne's heirs battle with ABC

SANTA ANA, Calif. — The ABC television network has filed suit against actor John Wayne's estate, claiming it is due more than \$500,000 reimbursement for contract obligations he failed to perform before his death last year.

The suit seeks the return of \$516,667 from a \$600,000 payment made to the actor shortly before his January 1979 gall bladder surgery.

ABC, which had signed Wayne to a two-year, \$2 million contract, filed the suit against Michael Wayne, the actor's son, and other heirs.

Army not seriously concerned over trainee abuse, study shows

WASHINGTON — Army drill sergeants need greater supervision and their commanding officers should be held accountable for any abuse of recruits, a House Armed Services subcommittee says.

The subcommittee's report was issued Wednesday, following an investigation into the deaths of two young soldiers. Despite the 1978 deaths and other incidents of abuse, the study said, the Army is not seriously concerned about the problem of trainee abuse.

The deaths at Fort Jackson, S.C., and incidents at Fort Dix, N.J., were "attributable mainly to the lack of effective supervision of drill sergeants at Army training centers," the report said.

The two Fort Jackson trainees died within hours of reporting to the base on June 29, 1978. Despite the intense heat and high humidity that day, the trainees generally were subjected to strenuous exercise, harassment and abuse, investigations later showed.

Another incident was reported the following month at Fort Dix, N.J., where 20 recruits were subjected to systematic abuse.

Rep. Sam Stratton, D-N.Y., subcommittee chairman, noted that following the Fort Jackson deaths, "no officer above the rank of captain was disciplined for that tragedy, let alone being court martialed."

"The very light sentences imposed on the sergeants found guilty of the deaths demonstrate that the Army is still not really seriously concerned

about trainee abuse," he said.

The subcommittee said that officers, including colonels and commanding generals, "also were held responsible for abuse that occurs in their commands."

At Fort Jackson, one drill sergeant was convicted of manslaughter, dereliction of duty and was sentenced to six months in prison and forfeited two-thirds of his pay for six months. The other sergeant was demoted and forfeited his pay for one month.

No major fire problems yet in Chicago

CHICAGO — Mayor Jane Byrne has refused to negotiate with firefighters, whom she called "lawbreakers," in the second day of the first strike ever by the city's firefighting force.

No major fires were reported by department officers who were staffing firehouses.

"We'll be all right as long as there are no fires," said 1st Battalion Chief James J. Higgins.

Byrne, who backed away from initial threats to fire strikers, said she would return to Cook County Circuit Court today and seek a preliminary injunction — and possibly contempt citations — against the firefighters, who ignored an earlier temporary restraining order.

"They're lawbreakers, and I won't have anyone sitting down with them," said the mayor, explaining the absence of negotiations.

Members of Fire Fighters Union Local 2, who struck early Thursday on their demands for a written contract, higher pay and increased manpower, said only 350 of the department's 4,300 firemen remained on the job.

The rest of the firefighting force was comprised of department officers and recruits as well as draftees

from other city departments who were placed on 24-hour alert during the walkout.

Union President Frank McHugh urged the city to accept a compromise plan to man the firehouses with only union officials. Mayor Byrne and Albrecht have rejected the proposal, saying it would place the protection at the mercy of the union.

Schools, large buildings, hospitals and downtown businesses were notified to put into effect emergency plans they had prepared for coping with a firemen's strike. Urban fire departments were prepared to lend assistance.
