United Press International VILANO BEACH, Fla. — Police searched Tuesday for a wealthy young housewife they believe shot her two small sons, left their bodies on a desolate stretch of beach and drove away in a gold Cadillac — perhaps to kill herself.

The pajama-clad bodies of Palmer Jackson, 3, and his brother Rhett, 5-months, were found Monday night after their father, Jacksonville busi-nessman Robert A. Jackson, found a three-page note from his wife saying she intended to kill the children and

Duval County police Sgt. C.F. Romine said blond Nancy Bauer Jackson, 32, apparently "had this obsession that her kids were sick and she couldn't cope with it" — even though a doctor had examined both

children recently and found them to be in good health. The two children were lying face-

down in a gulley on a narrow, spit of sparsely populated sand called Ponte Verdra, north of St. Augustine, a sheriff's spokesman said. Both had been shot once in the chest.

A Duval police spokesman said all units had been notified to look for the gold 1979 Cadillac Mrs. Jackson was believed to be driving when she left home shortly before 7 p.m. Romine said Jackson "talked with his wife (by talked how be bedded) his wife (by telephone) about 4 p.m. and everything seemed fine. She seemed completely rational and

apparently wasn't upset." Mr. and Mrs. Kenneth Smith, neighbors of the Jacksons, said she seemed devoted to her children "and always spent her days with them.

# Legal battle develops over estate and debts of Yankees' Munson

and her three young children — against Lloyd's of London, the prestigious international insurance firm. - Other impending legal battles extend from Canton, Ohio, to Wichita, Kan., and from Washington, D.C., to Los Angeles in an effort to establish what caused the crash of

Munson's aircraft and who, if Munson, is to blame for the form Yankee captain's death. The Press said Munson's est totals \$4.9 million, according

# **Allies upset** by U.S. polici

United Press International WASHINGTON — Sen. Jo Tower, R-Texas, said Tuesday was both reassured and worried discussions he had with Europe leaders during a defense seminar Germany.

Tower returned to the Unit States Tuesday following the 1 annual Wehrkunde Conference Munich, attended by congressio leaders, members of the British P liament and NATO officials.

He said he was reassured by t NATO allies' realization that Soviet invasion of Afghanistan wa grave threat to internation security

But he said our allies were tro bled by current U.S. leadership. "At a time when all agree on t

need for firm, united action, they deeply troubled by the vacillation uncertainty and confusion whi have typified administration pol statements," Tower said.

'They are shocked and offene by the ineptitud with which the views have either been taken granted or ignored and are dee dismayed by the confticting sign they have received."

Tower said he was confident th U.S. allies — "given clear U leadership" — were prepared to ta steps to deter further Soviet aggr
