Spy eludes federal agents, thought to be in California

LOS ANGELES — Spy Christopher John Boyce, who has eluded an international manhunt for eight months, may have been aided in his escape by Soviet intelligence agents, a federal investigator says.

At least one federal agent said Tuesday he believes the 27-year-old son of a former FBI agent may have taken refuge in a communist nation with the help of the KGB, but the U.S. Marshal's Service suspects Boyce could be hiding near his former home in southern California.

Boyce, a clerk on a CIA satellite project, was convicted in 1979 of selling thousands of top-secret documents to the Soviets. He escaped Jan. 21 from the federal prison at Lompoc, Calif., 150 miles northwest of Los Angeles.

"I wouldn't dismiss the fact that Boyce was helped by the KGB or is now in a communist bloc nation," an investigator who has worked on the case since January told UPI. He also said Boyce may have undergone plastic surgery.

A U.S. Marshal spokesman said, however, investigators do not think Boyce — who has been tentatively spotted in South Africa, Mexico and Alaska — ever left the area. If he did, they suspect, he has since returned.

Boyce, the son of a former FBI agent, grew up in Burbank Rancho Palos Verdes.

"The best information we have to date is the possibility of him being here now," said Chuck Kupferer, who is

in charge of a new task force of agents looking for Boyce. "This is an area of 20 million people. It's not too hard to get lost here."

But Kupferer also suggested Boyce might be hiding in a communist country. "We may find him somewhere we can't reach him," he said. "But we'll find him."

Investigators admitted there had been no positive sighting of the fugitive.

Boyce was convicted of stealing thousands of top secret documents from TRW Inc., a defense contractor working on a classified satellite project for the CIA. He sold the information to Soviet agents in Mexico City for \$70,000 with the help of a boyhood friend, Andrew Daulton Lee.

Lee claimed Boyce was working for the CIA and lured him into participating in a complicated espionage plot aimed at providing misleading intelligence to the Russians.

Boyce was sentenced to 40 years in prison and Lee got a life sentence.

Authorities recently enlisted the help of a psychiatrist, who specializes in criminal behavior, hoping to figure out how the fugitive might try to avoid capture.

The psychiatrist, who was not identified, told investigators it was "extremely likely" that Boyce would seek and receive the aid of Soviet agents.

He also suggested agents concentrate their search in Southern California.

US spy suspected of selling secrets

WASHINGTON — The Justice Department is investigating a former highly placed CIA agent on charges of selling secrets to the Russians, sources said Wednesday.

According to sources close to the investigation, the suspect is David Barnett. They said evidence has been presented to a grand jury and an espionage indictment or a guilty plea is expected before the end of the week in U.S. District Court.

The CIA had no comment on the story.

Barnett was said to have received \$100,000 from the Soviets for classified information on U.S. weapons.

Barnett worked as a contract employee for the CIA from 1958 to 1963 and then as a full-time staff member of the CIA's Directorate of Operations, which handles covert actions, the sources said. After 1970 he worked part-time for the agency.

The Washington Post reported Wednesday that Barnett tried unsuccessfully, on Soviet orders, to get a position with the Senate and House Intelligence Committees and the White House's Intelligence Oversight Board.

"It's the first time they've had accusations of a CIA covert agent passing secrets to the Russians," the newspaper quoted a source as saying.

Psychic has 'seen' murderer

Atlanta seeks child killer

ATLANTA — Police searching for leads to the killer stalking black children have pinned their hopes on a house-to-house canvass, a \$100,000 reward and a Nutley, N.J., psychic who calls the dead children "my little angels."

Dorothy Allison, accompanied by police detective from her hometown who has learned to "sort of" interpret her clues, told reporters "I guarantee he won't murder while I'm here."

"I will control him," she said. "I have seen who he is and I will follow him. I don't have complete control over him but I can control some actions."

She said she has given police the killer's name and description, but nonetheless plans to accompany them on a street-by-street search.

Police Chief George Napper said he brought Allison to Atlanta to help bring this nightmare to an end.

On an average of every 3 1/2 weeks for more than a year, a black child has vanished from a poverty area of

Atlanta. Ten of them have been found dead. Four are still missing. Two were girls, the rest boys, and their ages ranged from 7 to 15.

Police, working to calm parents on the edge of hysteria in black neighborhoods, are methodically conducting a door-to-door canvass throughout the city — in affluent white areas as well — in search of leads.

Private donations have swelled the reward fund to over \$140,000, but officials said they expected only \$100,000 — the original goal — would be offered for information leading to solution of the killings, and the rest would be used as rewards in other cases.

Allison referred to the killer as "he," and said "he" came from the Atlanta area, describing him as a "bully."

"I feel one of the children involved knew this person," she said.

"I didn't get the feeling of a racial thing here," Allison added, because she said the killer is also black.

"I don't want to say who, what, where or when," she said. "I will do

nothing that will hurt the police investigation."

Allison stressed she had a vision of the actual killings — but she did not know if the missing children were alive or dead.

"This is barbaric," she said. "This is despicable. Nobody touches my little angels — and that's what they are, my little angels — and gets away with it."

Allison claims she has solved 14 killings across the country. With her was Detective Sal Lubertazzi, who said "through experience, I've sort of learned to interpret for her. How you question her is very important. Her clues sort of get you where you're supposed to be, and then you take over from there."

Allison said she will ride with police through the city, instructing them where to turn, based on her "feeling and mental picture" in search of the killer.

"I was planning to stay just so many days, but if I see it taking any longer, I will stay until he is found," she said.


