

Hinckley arrested

United Press Internal LITTLE ROCK, Ark. Sources in the federal government said Monday that John Hinckley Jr. was arrested in Nashville, Tenn., in October 1980 for trying to board an airplane with several handguns, an Arkansas congressman said.

Rep. Bill Alexander, D-Ark., contacted for reaction to the Reagan shooting, said "my sources" told him of Hinckley's arrest on Oct. 9.

A brief psychiatric study done on Hinckley after his October arrest indicated that he "fit into a pattern similar to those found in people like Arthur Bremer (con-victed in the 1972 shooting of Alabama Gov. George Wallace) and Sirhan Sirhan (convicted in the 1968 death of Sen. Robert Ken-

der said.

Although he declined to reveal his source, Alexander called the information "airtight."


One of those guns was used Monday to shoot President Reagan and three other men.

Rocky's, located less than a half-mile from where Kennedy was killed nearly 18 years ago, was quiet Monday night.

A Bureau of Alcohol, Tobacco and Firearms transaction record shows Hinckley was in the pawn shop, which advertises itself as a discount headquarters for police equipment, on Oct. 13, 1980.

Pawnbroker Rocky Goldstein said he received a call from Washington asking him to check his records Monday afternoon.

"I'm already getting phone calls from people saying they are gonna blow this place up because I sold the gun," said Goldstein. "Did I


