Regents repeal drug rule at UT

United Press International AUSTIN — University of Texas System Regents agreed Monday to repeal a rule requiring the dismissal of any system employee given probation for a drug-related offense. The Regents also agreed to reinstate an employee at the Austin campus dismissed under that rule almost two years ago.

The agreement was part of settlement in a federal suit filed against the university system by Kurt Gregory, who was dismissed in 1979 as a store clerk after he was given probation on a charge of possession of LSD.

The rule required dismissal of any employee given probation for a drug related offense, even if the offense occurred away from the campus.

Gregory gained his previous job and was paid \$7,992 in lost wages and \$1,000 in attorney fees. The Grievance Review Board at UT Austin had recommended in



1979 that Gregory not be dismissed under terms of the rule governing university system employees, because a similar rule concerning students had been ruled invalid by a federal court.

But UT Austin President Peter Flawn overruled the Grievance Board, and Gregory was dismis-
