Brady may be able to visit home for Thanksgiving and could be permanently discharged from the hospital by then, one of his doctors said Tuesday.

Dr. Dennis O'Leary who last saw Brady Friday, said Brady is making very good progress in his recovery from a guestot wound in

recovery from a gunshot wound in the head which he suffered during the March 30 assassination attempt on President Reagan. Brady has been a patient at George Washington University

Hospital since the shooting, but since September has been allowed brief visits home — returning to the hospital at night,

Brady's wife Sarah told the Washington Post she and her hus-band hope he will be home permanently before Thanksgiving.

Mrs. Brady said he has made tremendous progress in the last four weeks and everything seems to be right on track

O'Leary echoed her optimism, but said "we can't be absolutely definitive" when Brady will be permanently discharged.



home video recorder, said Tuesday it plans to fight an appeals
court decision that some 3.5 miles urt decision that some 3.5 miln American households are iolating copyright laws by taping heir favorite TV programs and that home video recorder manu-facturers may be liable for dam-

Monday's far-reaching ruling by the 9th U.S. Circuit Court of ppeals said Universal Studios nd Walt Disney Productions had he right to sue Sony, four retailers, an advertising agency and a iewer for unfairly taping copyrght TV shows.




