The officials said on several occasions Masselli had worn a body microphone to meetings with people involved in Silverman's investigation and had worked for Silverman as an in-

Masselli is the son of William Masselli, 55, a reputed member of the Genovese crime family who emerged as a key witness in Silverman's renewed investiga-

#### tion of Donovan.

William Masselli is co-owner of Jo-Pel, a Bronx construction company that did business with schiavone Construction Co. of New Jersey, where Donovan was an executive before assuming his Cabinet post.

Silverman's June 28 report on the charges against Donovan disclosed Nat Masselli allowed the special prosecutor's investigators to tape four telephone conversations he had last May with Morris Levin, a lawyer for Schiavone

Two federal law enforcement officials familiar with Silverman's investigation privately have criticized the special pro-secutor for publicly disclosing Nat Masselli's willingness to permit the recordings.

But they said there was no evi-dence to indicate Masselli was slain for letting the special pro-secutor record the conversations. Silverman could not be reached for comment.


