
2 jailers indicted in civil rights case



25, of Port Arthur, and Donald Byron Parish, 26, of Sour Lake, are accused of the Nov. 16, 1981, beating of jail inmate Joseph ( Beaumont. Granger, 22,

ported beating in November, Granger filed a lawsuit in federal court saying he was held in solitary confinement for 21 days and beaten every day. The suit claimed he was refused medical attention.

Granger remained jailed on charges of burglary and escape from the Jefferson County jail last year. He was sentenced to 10 years in prison on a separate charge of burglary of a vehicle.
