Supreme Court denies appeal

'Candyman' still seeking reprieve

preme court Monday rejected and unusual punishment.

Charlotte Harris, a Houston Ronald Clark O'Bryan, leaving his attorneys to seek a reprieve from the Texas Board of Pardons and Paroles and Gov. Mark White.

The six parole board members voted unanimously to grant O'Bryan a hearing on his request for a 90-day reprieve just moments after they were informed his appeal to the Supreme Court had been denied. O'Bryan is scheduled to be executed early Saturday.

The six-member board set the hearing for 10 a.m. Tuesday and said it would hear arguments from O'Bryan's attorneys and lawyers for the state.

Earlier, the Supreme Court justices voted 7-2 to reject arguments that prosecutors at O'Bryan's trial illegally excused potential jurors if they were op-

posed to capital punishment.

Justice William Brennan and Thurgood Marshall dissented from the refusal to halt the execution and review O'Bryan's

O'Bryan's jury. She said two cases that dealt with similar questions of jury selection were currently pending before the U.S. Supreme Court and that O'Bryan's execution should be delayed until those cases were decided.
