Court upholds DA's conviction

AUSTIN — A former Hopkins ounty district attorney sentenced five years in prison for misusing ate funds lost his bid Wednesday to we his conviction overturned by e state's highest criminal appeals

The Texas Court of Criminal Apeals upheld the official misconduct onviction of Jack G. Neal, who was istrict attorney in the northeast exas county from 1973 to 1976.

Neal was convicted in 1978 of depositing in his own account a \$7,000 state check intended to pay his staff's salaries. He was sentenced to five years in prison and five years probation and ordered to pay a \$5,000


Evidence at Neal's trial showed he used some of the money for his secretary's salary but also drew checks on the amount for cash and to pay

non-business expenses.
In an opinion by Judge Tom G.

Davis, the Court of Criminal Apeals rejected Neal's contention fat his conviction should be overtured because he was forced to act a his own lawyer at his trial. The ourt also rejected Neal's argument deal-ing with jury selection and the trial judge's handling of the jury wdict.

In another case, the hin court upheld a Fort Bend Coury man's 10-year prison sentence fr possession of more than 4 ounce of marijuana, despite one judge's dissent that an off-duty Texas Ranger had no right to search the man's van.

Robert L. Marsh was arrested after the ranger, who was fishing on private property, noticed a low-fly-ing plane and several vehicles at a private landing strip. After the plane landed and the vehicles began driving away, the ranger stopped a van, discovered several bales of marijuana and arrested Marsh.
