Judge moves Port trial, orders gag

HOUSTON — A state district judge Monday ordered the trial of a 17-year-old accused of killing a mail carrier moved to another county because of extensive news reports and issued a gag order in the case.
Judge I.D. McMaster described the news reports on the slaying and the parents' refusal to testify as "overdone."
"I don't blame you all," McMaster told reporters after the brief hearing. "You've got your job to do and I've got my job to do. I'm trying to get this guy a fair trial."

The judge said that while he believes David Port can get a fair trial in Houston, he does not want to take the chance of a second trial being ordered on appeal. Port is charged with murder in the June 7 shooting death of Debora Sue Schatz, 23.
McMaster Monday also barred prosecutors from using as evidence several items found in Port's home and in his car that defense attorney Jack Zimmerman argued were illegally seized because they were not named in a search warrant.

Police have said bullet holes and blood found in the family's home and evidence found in the teenager's car indicate Schatz was killed in the house and transported in the car's trunk to a wooded area.
McMaster studied more than 700

newspaper stories, radio news scripts and television videotapes concerning the case before ruling to move the trial. He said no trial date will be set until he finds another court in which to hold the trial.

"I'm in contact with various and sundry places," he said. "I do not yet know where we are going."

McMaster also ordered Port, his attorneys, his parents and their attorney not to talk to reporters about the case "in any way, shape or fashion from this point forward."

"Obviously we want to do the best we can to obtain a fair trial for your client."

After winning his request for a change of venue, Zimmerman said, "I can't tell you how pleased we are in the Port case because the judge issued a gag order."

Much of the news coverage on the case has centered on the suspect's father and stepmother, Bernard and Odette Port, who went to jail for refusing to testify before a grand jury about the slaying.

The couple were jailed Sept. 12 for contempt but Bernard Port was freed Nov. 9 after meeting with the grand jury. His wife remains in custody because she has refused to answer six of the panel's 200 questions.
