Prostitutes to help police investigate organized crime

CONROE — Two women accused of working as prostitutes at a brothel run by a Texas prison inmate from his cell have agreed to help investigators in exchange for their free-dom, a prosecutor said.

Patsy Inez Perkins, 17, of Liberty, and Mary Catherine Hammons, 24, of Houston, were charged with engaging in organized criminal activ-

But Montgomery County District Attorney James Keeshan approved a "pre-trial diversion" agreement in which they provided information about the Hot Tub Club's operation.

Both women are now free but they must report to a probation offi-cer for one year or the charges could be reinstated, Keeshan said.

Perkins was arrested at the club March 28. Hammons was arrested in Houston last week for a traffic viola-

ton. Investigators said the club, located 10 miles north of Conroe, was a front for prostitution and was run by Raymond Carl Freda Sr., who was moved to Texas from New Jersey

under the federal witness protection program after testifying about his ties to crime boss Carlo Gambino.

Freda, 51, received a life prison sentence in 1981 for conviction of attempted arson.

Since he was indicted last month, Freda has been cooperating with Texas Department of Corrections officials investigating allegations that prison employees helped the inmate run the prostitution business from

the Eastham Unit near Lovelady. Two prison guards have been fired and two others have been suspended.

Still jailed on organized crime charges are Freda's wife, Dolores Conti, 44, and her brother, Tony Rubino, 34, both of Spring; and former prison guard Francisco Olivas, 23, of Trinity.

Olivas was not employed by TDC when he was indicted. He had been fired last year after prison officials found marijuana in his prison quar-


Freda's son, Raymond Freda Jr., 34, also is being held as a material witness in the case.
