TOKYO (AP) - Koito Manufacturing Co. said Thursday it will not give T. Boone Pickens Ir. more power just because he is increasing his stake in the Japanese auto parts supplier to 26 percent.

Pickens said Wednesday in Washington, D.C. that his Boone Co. — Koito's largest shareholder was buying another 10 million shares above the 32.4 million it currently holds but has no plans to mount a takeover battle.

He said he expected to request a special Koito shareholders' meeting in early October.

"We just don't have to allow Pickens to have seats on our board even though he increases the stake from 20.2 percent to 26 percent," Koito spokesman Mikio Tsuruta said. "There is no such law.
