

The dispute stemmed from a Golias was vice president of

Helena Laboratories Corp.; Ms. Snyder, his executive secretary. Golias and his wife A'lison

court documents said. A month later, Golias and Ms. Snyder had an affair, which lasted about six weeks.

sued Helena Laboratories, saying the company had a duty to prevent its employees from engaging in extramarital affairs.

parents, Tipton and Ann Golias, were principals in the company. Tipton was the president and board chairman.

But company officials said they knew nothing about the affair between Joe and Pam.

A district court in Beaumont ruled in favor of Helena Labora-tories, but the 9th Court of Ap-peals reversed that decision saying there were numerous ques-tions that had to be resolved.

Those questions included: What were Joe and Pam doing on corporate property and cor-porate time? What did Tipton know about the relationship and when did he know it? And what should Tipton or Ann have done about it?

Court overturned the appeals court and affirmed the trial favor of Helena Laboratories.
