

The following incidents were reported to the University Police Department between Sept. 8 and Sept. 12, 1995.

Indecent Exposure
Systems Loop - A nude man was observed operating a vehicle on the Systems Loop.

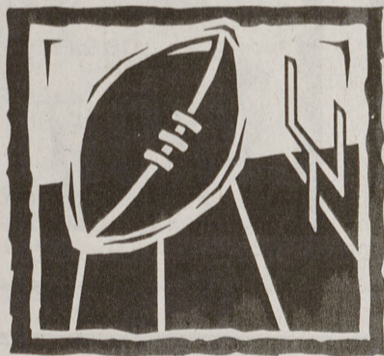

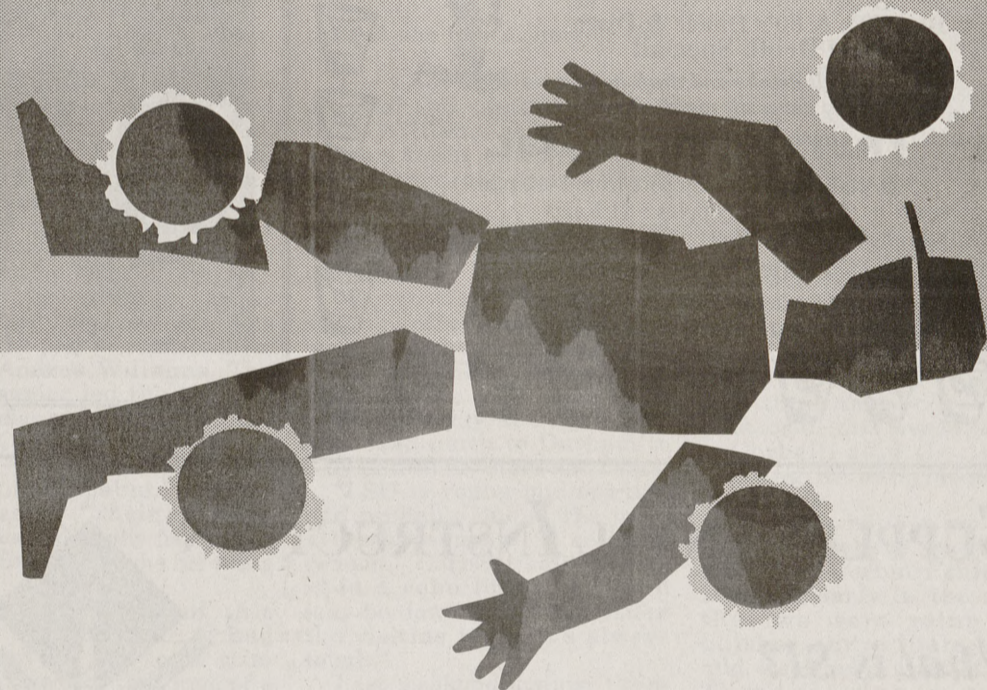
