

Murder verdict considerer in road rage jury selection Simpson charged, prison sentence possible

MIAMI (AP) — A woman who says she was beaten by her ex-husband and thought O.J. Simpson got away with mur-

der passed an initial round of questioning Wednesday in the former football great's road rage trial.

Jury candidates for the trial, which stemmed from an angry encounter between Simpson and a fellow driver Dec. 4, are being asked what they know about Simpson from his foot-

ball career and Hertz commercials to his movies and murder trial. The Miami charges of misdemeanor battery and felony auto-burglary carry a possible prison sentence of two to 16 years.

Prospective jurors were asked if they had firm opinions on Simpson's acquittal in the 1994 slayings of his ex-wife Nicole Brown Simpson and her friend Ronald Goldman. While cleared of criminal charges, he was later found liable in a civil trial. "In your mind, you think he did it and got

away with it?" defense attorney Yale Galanter asked. Prospective juror Marlen Heceverria replied, "Yes.


