Justice alerted to false testimony

WASHINGTON (AP) — Less than two weeks before Timothy McVeigh was executed, the Justice Department received a letter suggesting a key prosecution witness had given false testimony. Prosecutors didn't disclose the allegations to McVeigh's lawyers and later

sought to recover all copies of the letter in exchange for a lawsuit settlement.

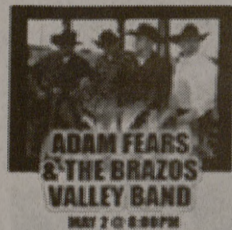
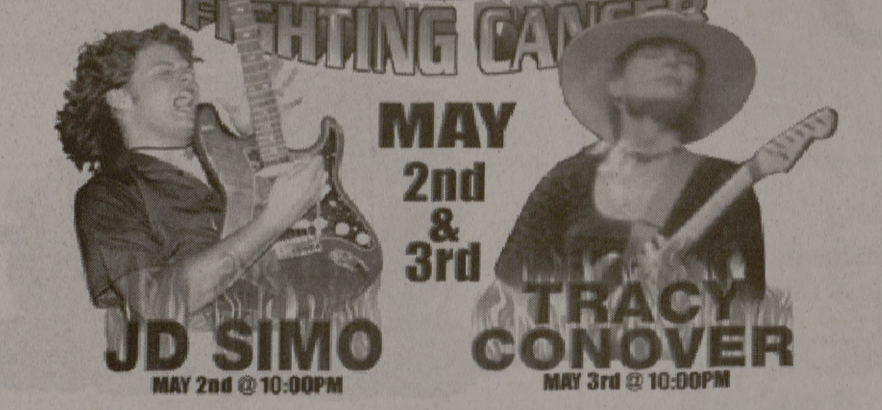
The letter, marked "urgent," was sent by fax and courier to the attention of Attorney General John Ashcroft on June 1, 2001, by a law firm representing several current and former FBI lab employees. At the time, a judge was deciding whether to delay McVeigh's

execution because of evidence the government withheld from his trial.

The letter's allegations involved Steven Burmeister, now the FBI lab's chief of scientific analysis, and were recently turned over to bombing conspirator Terry Nichols, who faces another trial on Oklahoma state murder charges.

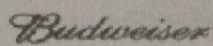

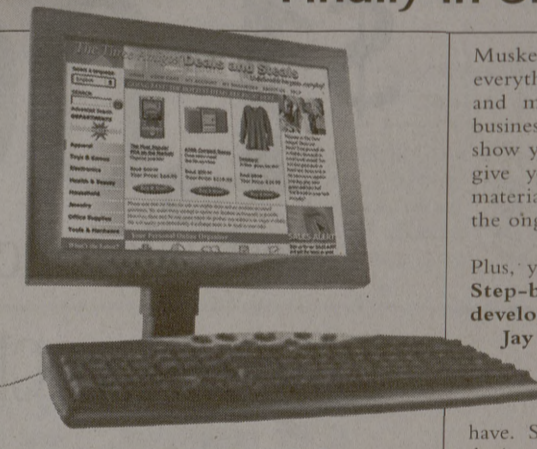

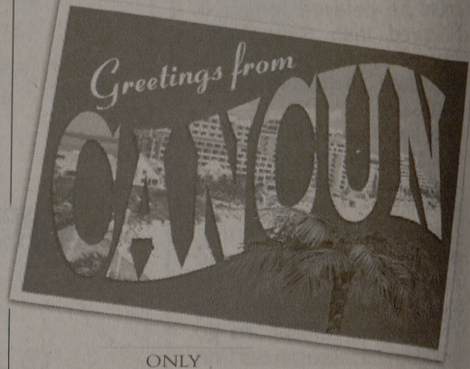
